Dayton Greenway Update

The Dayton Greenway Conceptual Master Plan is being prepared by the Design Assistance Center of Virginia Tech, and is scheduled for completion this month. The final designs to be included in the plan,

which show various phases of the greenway, potential trail locations, etc., are available on the Town's website at www.daytonva.us and at the Dayton Municipal Building for public review.

The Conceptual Master Plan will provide the Town with a vision as well as the documents needed to apply for grants to assist in funding this project. The proposed trail locations are subject to change and are dependent upon consensual agreements of property owners.

The Town of Dayton would like to thank the committee members, local residents and businesses, and other interested participants, for all their time and invaluable input in the design of this plan. Thanks also to the Community Design Assistance Center team for their exceptional work and professionalism in developing the Conceptual Master Plan. This plan was partially funded by a matching grant sponsored by the Virginia Department of Forestry Urban and Community Forestry and the U. S. Forestry Service.



Doggie Waste Bags

In an effort to help keep our neighborhoods free of dog waste, the Town is providing dog waste bags contained in plastic bone-shaped dispensers that are refillable and can be clipped on a leash. The Town also provides dog stations at our parks for convenient disposal of dog waste.

The dog waste dispensers are free to town residents while supplies last and may be picked up at the Dayton Municipal Building (one per household please). Vehicle litter bags are also available.

These items were made available by the Department of Environmental Quality Litter Prevention and Recycling Program. Dayton participates with Rockingham County in a cooperative program that combines annual grant funds to localities for litter prevention and recycling programs.

Chief's Corner

To my law abiding citizens, it would give me great pleasure to never again hear, "I'd no idea this sort of thing happens in Dayton..." Just know that "it" does, and with unpredictable frequency. There isn't a magic wall of impenetrability that encompasses our town's border from outside influence, and I think it is good when the veil obscuring our local criminal element is briefly lifted so that it might be viewed by the unsuspecting. I cannot help but grin as I'm forever amused by how blind we are to what we don't wish to see.

Don't push the panic button. Dayton is a *beautiful* place to raise a family, and I cannot think of a more fair statement to make of a community than that, and it can be even more so if you will more openly communicate with me.

I'm sure you know that our police force is small; made smaller over the past year and a half, training budgets slashed, etc., and we cannot remain effective without your involvement. I need your eyes, your ears, and your information. Please call 911 when you see a criminal activity, or when you need to speak to an officer concerning suspicion of criminal activity. The 911 center will dispatch us or relay to us the need to call you. Our office number should only be used to set appointments, or for non-

criminal conversation.

To those of you who are acting outside of the law, what you *don't* know is what I *do* know about you. My PD doesn't tout our successes. I keep most of it out of the paper on purpose. Those sitting in jail know of our abilities. You might be, "too good to get caught," as I've heard in the past, and maybe so, but those you associate with aren't. They will make a mistake.

For those of you stuck in the cycle of selling drugs or being addicted to them, here's an oversimplified example of how it ends for you:

1. *It started out innocently, believing you will maintain control of the drug because you are different than everyone else on the face of the planet. What's a little help with the stress of life? You trust whoever is introducing it to you and you try it.*
 2. *You like the escapism, and you felt great when high. You realize you've not felt great for a long time. What's wrong with feeling great? You do it more.*
 3. *You become reliant on the high. You can't stop because NOTHING else is as important as getting another fix—NOTHING. Not your kids, not your job, nothing else matters.*
 4. *Relationships and employment become impossible to maintain. You lie, you steal, and you do anything necessary to get high.*
 5. *Your world becomes one of paranoia, but you still aren't making mistakes that will get you caught.*
6. *But ... your buddy gets pulled over because a taillight is out and the officer notices an illegal item within the vehicle.*
 7. *During the subsequent arrest, your buddy decides that he/she has information that they are willing to give if it can help their legal situation.*
 8. *If we aren't already aware of you, your "buddy" reveals you and is willing to make a buy from you because he likes you and all, but he likes jail less.*
 9. *We begin an investigation that leads to your arrest.*
 10. *Your world remains full of paranoia. You have to decide if you want to tell us where your drugs come from ... and you're still likely to go to jail ... just maybe for not as long, if you help us by making buys. Your choice.*
 11. *Either way, you get clean, rearrested or die.*

Rather than experience the above scenario, I'd rather you come visit me at my office and say, "You know what, I'm tired of living this way. I'm tired of the fear, tired of the addiction, tired of the abuse, tired of it all. Help me help myself." Something that bold would gain you a supportive relationship with my police department, rather than a life of constantly looking over your shoulder, wondering if your luck is running out.

This "Chief's Corner" was written prior to a recent incident on Mason Street in which a thirty-something year old male overdosed on heroin. A Good Samaritan stopped to render aid, and an alert business owner called 911. Dayton Officer Devin Clark responded and initiated CPR, and alongside County Fire/Rescue successfully resuscitated the victim. The subsequent DUID investigation revealed that the victim had also overdosed, died, and had been resuscitated in February of this year in another jurisdiction. Addiction is a beast—so monstrous that even the likelihood of death doesn't matter. Please, please, please, GET HELP!

- 📍 College Street Pavilion is located at 360 College Street in Historic Dayton, Virginia. The summer event schedule is subject to change, so please visit our town Facebook page, call 540-879-2241 or visit our town website: www.daytonva.us/community/events, for the most up-to-date information. Since parking at the pavilion is limited, we encourage residents to walk or pedal to the pavilion for events if they are able. While the summer events are hosted for Dayton residents, friends and family who live outside of Dayton are also welcome.
- 🎵 Music events are \$5/person; 12 and under are free. If you bring a \$5+ receipt from a purchase made at any Dayton merchant from the day of a live music event, your entrance fee is waived. One receipt per person, and one person per receipt. "21 and older" coolers are allowed at live music events and will require an ID check and wristband.
- ❤️ The Dayton Muddler is a unique 3.2 mile adventure course through the Town of Dayton, with proceeds benefiting our nation's wounded warriors. Individual, Team and Youth races are available. Early registration for Individuals is \$50 until June 1st; \$60 after June 1st. Youth registration is \$20 for ages 10-15. Pre-registration is strongly recommended. Visit www.daytonva.us/muddler for additional information.
- ❤️ The July 4th Block Party (on July 2nd) is the perfect way to celebrate Independence Day. Enjoy a town potluck, kids water activities, tie dye, and sunshine at the pavilion. The Town will provide hotdogs and hamburgers at 1:30pm, and everyone in the town is encouraged to bring a side dish to share. "21 and older" coolers are allowed. It's going to be a great day in "Small Town USA".
- 🎬 Movies are free of charge and are displayed on a 16'x9' blow up movie screen. Accepted materials:

- Oil-based paint, solvents, spent fuel, motor oil, syringes and needles, pesticides, herbicides, lead acid and dry cell batteries, fluorescent lights, antifreeze, and cleaners. Materials must be in original containers. Collection will be limited to 5 units per household per event.
- Materials must be labeled and in their original containers.
- Protect yourself and visit the US Environmental Protection Agency's website for information on how to package and transport a mercury containing device to the collection site.
- No containers over five gallons in size.
- No latex paint
- No chlorinated solvents (methylene chloride)
- No regular recyclables. Please place them out for regular weekly collection.

What is household hazardous waste?

Household hazardous wastes are defined as leftover household products that contain corrosive, toxic, ignitable, or reactive ingredients. Products such as paints, cleaners, oils, batteries and pesticides that contain potentially hazardous ingredients require special care when you dispose of them.

Improper disposal of household hazardous wastes can include pouring them down the drain, on the ground, into storm sewers, or in some cases putting them out with the trash. The dangers of such disposal methods might not be immediately obvious, but improper disposal of these wastes can pollute the environment and pose a threat to human health.
