#### Water Treatment Plant Upgrade Underway

The Town of Dayton provides safe drinking water to approximately 650 residential, commercial, and industrial customers. The Cargill processing facility is the largest water customer by a significant margin. Cargill uses almost 80% of the water the Town produces. The Town treats water from three well sources and the Town also has the ability to pull water from Silver Lake which we do very sparingly. There are times when we need to purchase water from the county as well.

Our current plant was constructed in 2000. In recent years, we have had performance and maintenance issues, with the filter modules being replaced at least once. As performance drops, more chemical cleanings and maintenance are needed, and the rate at which we can treat the water is reduced.

The plant upgrade will allow us to restore capacity and provide a system with greater reliability than the existing system. A study was completed in April, 2020 after which recommendations were made. The Preliminary Engineering Report was approved by the Virginia Department of Health in 2020. The total cost of the plant upgrade was estimated to be \$3.8 million. We planned to purchase the equipment with existing investments on-hand. We applied for financing for the construction and installation portion of the project (~1.9 million) through VDH. Since that time, we have received American Rescue Plan Act Funds (~\$1.7 million) and plan to finance the entire project ourselves. The equipment for the plant has been ordered and is expected to be ready for shipment in June. Bids for the construction and installation of the new building and equipment are due in February. Assuming we receive good bids, we should be able to award a contract at the February 14 Town Council meeting. As with all industries currently, there may be supply chain issues related to pipe or building materials; however, we project that the new equipment will be up and running by the end of this year.
